Program Permissions Form

FIELD TRIPS

The Mid-Peninsula Boys & Girls Club will periodically take field trips during our programs. We are asking for your written consent to take your child on field trips within the geographic range of the Mid-Peninsula Clubhouses. This includes Daly City, Millbrae and San Mateo districts. This authorization will eliminate the need for special permission before each trip and will assure each child an opportunity to be included in these outings.

The Mid-Peninsula Boys & Girls Club will provide transportation for field trips. On occasion, Club members and staff may walk to a location within reasonable distance and during pleasant weather.

This permission form covers field trips within the city where my child's club is located and from one Mid-Peninsula Boys & Girls Club and another. For any other field trips we will require you to fill out a special permission form.





Pick Up Authorization and Walk Home Permission

We will not release your child to any person not listed on this form. Please give names and working phone numbers. Please include yourself and the emergency contacts that were previously listed. If a new person is picking up your child you must send verbal or written confirmation prior to us releasing your child. We will check identification as necessary. You may update this form or list by adding names, signing and dating as well as crossing names out signing and deleting. Speak with your Unit Director or Membership Coordinator if you need to update your authorization list at any time.

PARENT/GUARDIAN- I hereby give my permission to my son or daughter to become a member of the Mid-Peninsula Boys & Girls Club. It is expressly understood and agreed that the Mid-Peninsula Boys & Girls Club shall not be responsible or legally liable for any losses of personal property or for any bodily injuries, or the results thereof, incurred and suffered by the applicant on any property of the above named Club, or in connection with any activities of any of its Branches, unless such loss or injury results directly from negligence or willful act of an employee of the Club named above acting within the scope of their employment.

All member information will be kept confidential and retained in secure files. This information will be used to document membership, demographics, and evaluate program effectiveness within our organization and for funding purposes. Individual information will not be shared or sold to outside agencies. Surveys and other assessments may be conducted by the Mid-Peninsula Boys & Girls Club and Boys & Girls Club of America for the purpose of program evaluation, development, and needs assessment.

IN CONSIDERATION of being permitted to enter the Mid-Peninsula Boys & Girls Club for any purpose, including but not limited to observation, community service work, volunteer work, use of facilities or equipment, or participation in anyway, the undersigned, for himself or herself or any personal representatives, heirs, minors and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering will, inspect such promises facilities. It is further warranted that such entry into the Mid-Peninsula Boys & Girls Club for observation, participation or use of any facilities or equipment constitutes an acknowledgment that such premises and all facilities and equipment thereon have been inspected and that the undersigned finds and accepts same as being safe and reasonably suited for the purposes of such observation or use.

THE UNDERSIGNED WARRANTS THAT THE PARTICIPANT, INCLUDING ANY MINOR PARTICIPANT, has no physical or medical condition which would endanger the participant or others, or that would interfere with the participant's ability to participate in the Mid-Peninsula Boys & Girls Club event/program.

THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the Mid-Peninsula Boys & Girls Club, its directors, attorneys, officers, employees, and agents (herein after referred to as "release") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein.

THE UNDERSIGNED HEREBY AGREES TO INDEMNITY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in, upon or about the Mid-Peninsula Boys & Girls Club premises or in any way while volunteering, observing or facilities or equipment of the Mid-Peninsula Boys & Girls Club whether caused by the negligence of the releases or otherwise.

THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of release or otherwise while in, about or upon the premises of the Mid-Peninsula Boys & Girls Club and/or while using the premises or any facilities or equipment hereon.

THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases against all liability costs or expense for attorney's fees and all incidental and consequential damages resulting to the Mid-Peninsula Boys & Girls Club from such claims, lawsuits or liens. In the event any suit on any claim is brought against the Mid-Peninsula Boys & Girls Club, the undersigned shall defend said suit at undersigned's own cost and expense, and shall pay and satisfy any such lien or judgment as may be established by the decision of the court in such suit.

MEDICAL AUTHORIZATION.
